- Who have more than 3 mortgaged BTL or Holiday Let properties.
- Who are looking to purchase or remortgage in their personal name.
- Do not meet our lending or property criteria.
- Are looking for a mortgage on a HMO property.

Customers with characteristics of vulnerability
